# From our Executive Director— Barbara Kuhn

On average, a woman will leave an abusive relationship seven times before she leaves for good.

The National Domestic Violence Hotline

Can you imagine? Or perhaps you can imagine all too clearly.

She runs from her home, taking only her three young children.

No packed clothes.

No food.

No place to stay.

Forgetting her identification documents.

Only focused on getting away from the domestic violence that haunts each day.

Yet, now, new burdens arise:

The fear of filing a police report.

The fear of seeking a Protective Order—which leaves the abuser free to hunt for her.

She's on the run. Always looking over her shoulder.

She seeks help through RCVA, but she chooses housing farther away, afraid to stay in the same county where he may see her car.

Through the services of RCVA and friends, she travels two counties away, guided to a Domestic Violence Shelter that can house her and the children for several weeks.

Still, she can't neglect her job and the little financial security it provides.

Now begins a new marathon every morning: getting the children up early to drive to child care in another county, then driving to a third county for her job, only to retrace the long miles in the evening.

When does time and energy permit her to create a new life plan?

There are so many obstacles to creating a peaceful, productive life.

How does she get the belongings the children need for daily comfort?

How does she assure them amid so much uncertainty?

Where will the children be enrolled in school?

Where will they live?

How can she pay for everything alone? Her parents have passed. She has no siblings.

Finally, she acknowledges that a Protective Order is the only way to legally protect herself, her family, and provide a safe space to be. RCVA is there to help.

There must be a court hearing for the judge to grant a two-year continuance on the Protective Order. But she does not face this alone.

RCVA is beside her, preparing her for what to expect and how to respond.

"He" hired an attorney who asked inappropriate questions, "Did you report the abuse? Why didn't you report the abuse? Are you on medication?" Intimidation is part of the legal ploy. Yet, this brave woman answered all the inappropriate questions appropriately. She was calm and forthright with the judge. She held her own. And the judge, examining all the evidence, granted the extended Protective Order.

Now, she can safely return to her home county. RCVA is assisting in the many previous obstacles. She will soon move into a new home. Her children will be enrolled in school. She has secured a new, better paying job.

Yes, there are still many challenges before her in the long months of this new beginning. But, this time, she is not alone. With her consent, RCVA will assist this family not only through the initial crisis, but through the lengthy process of establishing a secure life, in whatever way is needed.

RCVA is here to break the seven-time-pattern and empower every client to stand on their own, living respected, worthy lives.

She relaxes through time with friends on the Women's Golf League and, as she says, "coaxing flowers to bloom."


