#### It's Time to Wake-Up to Cyber Violence

Cyber violence is just as damaging to women as physical violence, according to a recent U.N. report, which warns women are

growing even more vulnerable to cyber violence as more and more global regions gain internet access.

The report estimates that 73% of women have endured cyber violence, and that women are 27 times more likely as men to be harassed online. Cyber behavior by a partner, family member or someone else is abusive if it makes you feel scared or unsafe.

Abusive cyber behavior includes:

- -Checking your email or tracking your internet use
- -Impersonating you or spreading rumors about you
- -Posting embarrassing, fake or intimate videos, photos or comments about you
- -Constantly messaging, emailing or texting you in a way that makes you feel intimidated or scared
- -Harassing you on social networking sites such as Face book, Twitter, MySpace or dating/chat/game sites.

If anyone – including a family member, boy/girlfriend or partner – is doing this to you, remember: you don't have to put up with it.

What to do? Be sure to create a *Technology Safety Plan*, such as the following:

#### Technology Safety Plan

#### **Trust your instincts**

If you suspect the abusive person knows too much, it is possible that your phone, computer, email, or car use are being monitored.

#### There is help

Dealing with violence is very difficult and dangerous. RCVA and law enforcement are valuable resources to discuss safety options.

#### Use a safer computer

If an abuser has access to your computer, he/she might be monitoring your computer activities. 'Spyware' and 'keylogging' programs are commonly available and can track you unawares. It is not possible to delete or clear all of the 'tracks' of your online or computer activities. Use a safer computer when you look for help, a new place to live, etc. It may be safest to use a computer at a public library.

Inspect your car

GPS tracking devices can be attached to your car, especially in wheel wells, undercarriage, rear bumper, dashboard area, consoles. A trusted auto mechanic can assist you in this search.



# Create a new email, Facebook or instant messaging account

Be proactive at all times! If you suspect that an abuser can access your social media, create an additional account on a safer computer. Do not create or check this new account from a computer your abuser could access and monitor. Use an anonymous name, and do not provide detailed information about yourself. Create a new free web-based email account, such as yahoo, gmail, or Hotmail.

#### Change passwords and pin numbers

If anyone abusive knows or could guess your passwords, change



them quickly and frequently. Change the passwords for any password protected accounts – online banking, voicemail, etc. Use a safer computer to access your accounts.

#### Get your own cell phone

When making or receiving private calls or arranging escape plans, do not use a shared cell phone because the phone bill and the phone log might reveal your plans to an abuser. When

necessary, RCVA can provide a secondary phone for a client, or adolescents, when the abuser has confiscated their phone. This is a basic cell phone with limited minutes for emergency use, or for an adolescent to contact the non-abusive parent for safety reasons.

If you must use a cell phone provided by the abuser, switch the location feature off/on via the phone settings menu or by turning your phone on and off when not in use.

## Get a private postbox and don't give out your real address

When asked by businesses, doctors, and others for your address, have a private post office box address or a safer address to give them.

#### Google yourself

See if your private contact information can be found online. Go to Google and do a search for your name in quotation marks: "Full Name"

#### Save evidence and report abuse

Messages left via texts, voicemail, an-

swering machines can be saved as evidence of stalking or abuse.
